Introduction & Overview

Iron Horse operates as a private Club. It is the intention of the Board of Directors to promulgate the fewest rules necessary to balance the freedoms enjoyed by Members of the Club and a set of policies to preserve Members' enjoyment of the Club and its facilities.

In accordance with the Bylaws of the Club, it is expected and required that each Member of the Club conduct themselves in a manner that is respectful of other Members and their enjoyment of the Club and its facilities.

Additionally, in accordance with the Bylaws of the Club, the Board of Directors, from time to time, may add to, delete and/or change any rule or regulation of the Club as it deems necessary.

Member/Family Use Privileges

Immediate Family

An Equity Member's immediate family is defined as the member's spouse and the unmarried children of either spouse under the age of 23. The immediate family of a member will be entitled to use the Club facilities on the same basis as the Member. At least one Primary Member and/or Spouse must be in each 4/5 ball (golf group) before 12pm all season.

Extended Family

The Extended Family of a Primary Member will be entitled to use the Club facilities, but shall be subject to restrictions and pay fees as determined by the Board of Directors from time to time. The Club may modify or terminate this privilege and establish such rules with respect thereto as it may determine (Bylaws Article X, Section 5). Please see rules below.

1. All Extended Family will not be able to host guests on the Golf Course during July.
2. Adult Extended Family (23 years and older) will be limited to 12 days of golf per year.
3. Extended Family (23 years and older): \$95
4. Grandchildren under 23: \$50
5. At least one Primary Member and/or Spouse must be in each 4/5 ball (golf group) before 12pm all season.

Social Member Golf Privileges

Prior to October 1, Social Members are subject to the guest policy when playing golf (must be accompanied by a Golf Member and pay guest fees). After October 1, Social Members may play golf up to 6 times per calendar year unaccompanied without paying guest fees.

Definitions:

- A. Primary Member or Spouse: the adult equity owner of a membership.
- B. Immediate Family: children of the Primary Member and/or Spouse under the age of 23.
- C. Extended Family: parents, grandparents, adult children (children who do not fall within the Immediate Family definition) and grandchildren of the Primary Member and/or Spouse.
- D. *Host* Member: All of the above (A, B, & C).

General Club Rules and Regulations

- In no case shall any Member or his/her guest reprimand, verbally abuse or intimidate an Iron Horse Golf Club employee. Any problems that a Member or guest may have should be addressed to the General Manager. Violation of this policy may result in the suspension or expulsion of the offending Member at the discretion of the Board of Directors.
- Members are accountable for the behavior of their guests. Violation of the rules by guests, accompanied or otherwise, will be treated as a violation of the Member.
- Commercial advertisements shall not be posted or circulated in the Club nor shall solicitations of any kind be made on the Club Facilities or using the Club's name or logo without prior approval of the Board of Directors.
- It is contrary to the Club's policy to have the facilities used for functions which are in any way related to past, present or future fund raising efforts for the benefit of a political cause, except as specifically permitted by the Board of Directors. The Club Facilities shall not be used in connection with organized religious services unless otherwise determined by the Board of Directors from time to time.
- Iron Horse is a non-smoking facility. Smoking is permitted only in designated areas. Smoking is permitted on the Golf Course subject to restrictions/prohibitions implemented by the Board of Directors at its discretion from time to time.
- The carrying or use of firearms is prohibited anywhere on Club property except by duly authorized police, security forces, or employees in the performance of their duties.
- Fireworks of any kind are not permitted anywhere on Club property or adjacent areas unless part of a fireworks exhibit organized and conducted by the Club.

General Club Rules and Regulations Continued...

- Motorcycles, ATVs, mopeds, non-conforming golf carts/scooters, etc. are not allowed on Club property (except for designated automobile parking lots).
- When the Pony Express is open, the Dog Show is available to golfers only.
- All dining areas of the Club will be considered PET-FREE ZONES, including but not limited to: bar/dining rooms, patios, pizza kitchen, Pony Express, Pool, etc. Exceptions: registered service dogs on a leash with ID tags and dogs in a carrier or container.
- The use of cell phones is permitted on Club property but only in “silent” or “vibrate” modes. Should a call be received on any Club property where other Members are present, the Member or guest is expected to depart the immediate area so that other Members and guests cannot hear the conversation. A general standard of courtesy to fellow Members is expected and required.
- Cash tipping is not permitted at any Club facility, including valet services, with the exception of caddie, marina, and airport shuttle services. The Staff Holiday Fund has been established to provide a means of saying “thank you” to the staff of Iron Horse at the end of each year. A reminder will be sent to the membership in November so that those who would like to contribute may do so.
- Children may not sit at the bar unless accompanied by an adult.
- No person shall be permitted to enter into any of the Club lakes or ponds for any purpose.
- Swimming, diving, and boating are not permitted at Fish Camp.

- Each player will receive the applicable cart fee, unless otherwise walking the Golf Course.
- Members and guests will receive the maximum fee of 18 holes and one cart fee per day. If a group plays more than 18 holes, further charges will not be incurred.
- A guest may charge their guest, cart, and caddie fees via credit card only if approved by the *Host* Member.

Junior Golf Guest Fee Information:

- Junior guest fees have been established for guests 22 years and younger.
- Golfers must be 16 years of age and have a valid automobile driver's license to use a golf cart and will be charged a cart fee accordingly.
- Golfers under 16 years of age must be accompanied by an adult at all times (including at the Practice Facility).
- Dispensation may be granted for junior golfers that have demonstrated the necessary understanding of golf etiquette, play proficiency, and maturity at the discretion of the Club's Head Golf Professional.

*Cart passengers under 16 years of age will not be charged a cart fee.

Golf Event/Tournament Eligibility

Campbell Tournament (Member-Member)

- The participant must be the Primary Member.
- Extended Family may play as the Member (participant) provided that the Tournament is not full 10 days prior to the Tournament Date.
- Immediate Family (children) may play with the Primary Member provided that the Tournament is not full 10 days prior to the Tournament Date.**

Roundup (Men's Member-Guest) & Ladies' Invitational Tournaments

- The participant must be the Primary Member.
- Extended Family may play as a guest of a Primary Member.
- Extended Family may play as the Host Member (participant) provided that the Tournament is not full 10 days prior to the Tournament Date.
- Immediate Family (children) may play with the Primary Member provided that the Tournament is not full 10 days prior to the Tournament Date.**
- Members may play together provided that the Tournament is not full 10 days prior to the Tournament Date.

Club Championship

- The participant must be the Primary Member.

***Primary Member is defined as the adult equity owner of a Membership and/or spouse.**

****Immediate Family (children) must be at least 21 years of age to play in these events.**

Guest Policy

All guests at Iron Horse shall be either “Accompanied Guests” or “Unaccompanied Guests”. An Unaccompanied Guest is defined as a registered guest of a Member with an account set up at Iron Horse who may use non-golf Club facilities while not in the company of a Member. All other guests of a Member shall be considered Accompanied Guests.

Golf Guests

There will be no Unaccompanied Guest play allowed on the Golf Course or Practice Facility at any time. All guests must be accompanied by the sponsoring *Host* Member when using the golf facilities and are limited to six rounds per year.

Accompanied Guests

- Accompanied Guests must be accompanied by the sponsoring *Host* Member when using the golf facilities or any other Club facilities, unless otherwise determined by the Club from time to time.
- The *Host* Member shall be responsible for all charges incurred by the guest and for the conduct of the guest while at the Club.
- An Accompanied Guest is limited to no more than six rounds of golf per season, regardless of the *Host* Member, unless otherwise determined by the Club from time to time.

The Club may modify or terminate this privilege and establish such rules with respect thereto as it may determine from time to time.

Unaccompanied Guests Privileges for Non-Golf Facilities

- Unaccompanied Guest privileges for the sole purpose of using non-golf Club facilities will be extended to guests of a Member who have been officially registered by the Member. There will be no Unaccompanied Guest play allowed on the Golf Course or Practice Facility at any time.
- There will be no Unaccompanied Guest privileges for non-golf, golf, or Club facilities during the month of July. Use of non-golf Club facilities may be granted in months other than July upon official registration of guests through the Club office.
- Unaccompanied guests are limited to **one visit (maximum 14 days) per lifetime**. Following this visit, guests must be accompanied by a Member at all times while using Club facilities.
- The *Host* Member shall be responsible for all charges incurred by the guest and for the conduct of the guest while at the Club. An Unaccompanied Guest account may be set up if desired; however, the guest's credit card and other information must be submitted to the Club prior to arrival.
- The *Host* Member must initiate an application at least five business days prior to the arrival date of the guest.
- Members may not sponsor any more than eight Unaccompanied Guests at the same time.

Golf Rules and Course Etiquette

- At least one *Primary Member and/or Spouse* must be in each 4/5 ball (golf group) before 12pm all season. The Golf Shop will be encouraged to arrange 4balls/per tee time before 12pm (i.e. singles and twosomes will be paired).
- Each 4ball/5ball must have at least one *Host Member* in the group at all times, all season.*
 - *exceptions may be made before Father's Day and after Labor Day at the discretion of the Head Golf Professional.
- To ensure proper pace of play with adequate group spacing, we highly recommend you schedule tee times with the Golf Shop. On a limited basis, members may schedule tee times in advance to plan their important summer dates. Recurring tee time requests can only be made up to one month in advance and for no more than 2 per week. To ensure member equity, tee times are scheduled at the discretion of the Head Golf Professional. *Tee time policies subject to change.*
- A member who does not intend to use a scheduled tee time should cancel sufficiently in advance to allow the tee time to be used by another member.
- When the Pony Express is open, the Dog Show is available to golfers only.
- Slow play seriously detracts from an enjoyable game of golf. It is the Club policy that all rounds of golf at Iron Horse shall be played in an allowed time of four hours. Habitual violation may result in restrictions and/or suspensions of the Member's access to the Golf Course at the discretion of the Club's Head Golf Professional.
- If your group is moving slowly, please allow faster groups to play through. However, groups of three or less should not expect to play through if the Golf Course is busy. Groups falling more than one full hole behind the group in front should make every effort to catch up or allow the following group to play through.
- Groups choosing to stop for lunch at the turn may lose their standing on the Golf Course.

Golf Rules and Course Etiquette Continued...

- Members wishing to play music on the Golf Course or Practice Facility may do so as long as the volume is limited to a level that does not bother or distract fellow players. A general standard of courtesy is expected and required by all Members and their guests. If any Club employee directs a Member or guest to limit the volume or otherwise discontinue music on the Golf Course or Practice Facility, the Member or guest is required to promptly comply.
- Each golfer must have his/her own clubs and bag.
- Practice balls are property of the Club and are not to be removed from the Practice Facility.
- Please repair ball marks on greens.
- Please replace all sizeable divots in fairways. Sand is provided on golf carts for small and obliterated divots that are unable to be replaced.
- Carefully rake bunkers after use.
- All play should begin at No. 1 tee unless permission is granted by the Golf Shop or Starter to begin elsewhere.
- If lightning is in the area, all play shall cease.
- Jogging, bicycling or recreational walking is not permitted on the Golf Course after 8 am.
- Pull carts are permitted for Junior Golfers under 16 years of age (restrictions may apply).
- The Rules of Golf as adopted by the U.S.G.A., together with the Rules of Etiquette as adopted by the U.S.G.A., shall be the rules of the Club, except when in conflict with local rules or with any of the rules and regulations herein.

Golf Carts / Finn Scooters

- **EACH DRIVER OF A GOLF CART MUST BE AT LEAST 16 YEARS OF AGE AND HAVE A VALID AUTOMOBILE DRIVER'S LICENSE. EACH DRIVER OF A FINN SCOOTER MUST BE AT LEAST 25 YEARS OF AGE AND HAVE A VALID AUTOMOBILE DRIVER'S LICENSE. FAILURE TO COMPLY WITH THIS RULE MAY RESULT IN THE SUSPENSION OF THE PRIMARY MEMBER AT THE DISCRETION OF THE BOARD OF DIRECTORS.**
- The only scooter that may be operated on the Golf Course or on Club property is a Finn-brand Scooter. The maximum speed for operation of a Finn Scooter is 15 mph.
- Carts/scooters are not to be driven in areas where fescue and/or native grasses are present. Carts/scooters can only be driven on cart paths or blue grass fairway areas of the Golf Course. Violation of this policy may result in the suspension of cart/scooter usage by the offending Member.
- Club owned carts may only be operated on Club property in appropriated designated areas. Club owned carts may not be operated on streets within Iron Horse (aside from the designated cart/path lane to and from the Practice Facility) or taken off Club property to include:
 - *Cabins or other private residences
 - *The Larkspur or Silverberry Pools
 - *The tennis/pickleball facility
- Operation of a cart/scooter is at the sole risk of the operator. The Club shall not have any liability to any Member or guest for damage or injury resulting from operation of a cart/scooter. Members are responsible for any damage or injury resulting from operation of a cart/scooter by themselves or their guests.
- Carts/scooters are not permitted within 50 feet of the front, side, or back of any green or tee unless on a cart path.
- Privately owned carts/scooters must be **REGISTERED** with the Club to operate on the Golf Course (with the exception of the use of generally designated automobile parking lots). A registration/trail fee will apply and a valid contract must be executed by the Member. Only green carts with specifications matching Club owned carts and only Finn Scooters will be accepted. Any non-registered cart/scooter is not permitted on the Golf Course.

Locker Rooms and Fitness Facility

- No female children over the age of 3 will be allowed in the Men's Locker Room and no male children over the age of 3 will be allowed in the Ladies' Locker Room.
- It is the responsibility of all persons who intend to use the Fitness Facility to consult with a physician prior to physical exercise, or use of any exercise equipment.
- Use of the Fitness Facility is at the sole risk of the user. The Club shall not have any liability to any Member or guest for damage or injury resulting from use of the Fitness Facility.
- Members and guests agree to hold the Club and its directors, officers, and employees harmless from any and all injuries sustained from the use of the Fitness Facility.

Tennis/Pickleball

- Court reservations are not required; please limit play to 45 minutes if others are waiting.
- Lessons scheduled with a Club professional have priority over all other play. Lessons can be arranged through Outdoor Pursuits
- Racquets, balls, and a ball machine are available for checkout at the pool facility during Pool hours.
- Proper attire is required at all times, including shirts and regulation shoes. Black soled shoes are not permitted.
- No skateboards, hover boards, scooters, bicycles, roller blades, etc. are permitted on the courts.
- Members wishing to play music on the courts may do so as long as the volume is limited to a level that does not bother or distract fellow players. A general standard of courtesy is expected and required by all Members and their guests. If any Club employee directs a Member or guest to limit the volume or otherwise discontinue music on the courts, the Member or guest is required to promptly comply.

Swimming Pool, Pool Hot Tub, & Cold Plunge

- A general standard of courtesy is expected and required by all Members, guests, and children. The Club reserves the right to remove anyone not observing this standard of courtesy. Habitual violation of the rules may result in the suspension of use of the Pool facilities by the offending Member, guest, or child at the discretion of the Club's Board of Directors.
- Use of the Pool and hot tub is at the swimmer's own risk. The Club shall not have any liability to any Member or guest for damage or injury resulting from use of the Pool facilities.
- Members and guests agree to hold the Club and its directors, officers, and employees harmless from any and all injuries sustained from the use of the Pool facilities.
- Children under the age of 10 must be accompanied by a responsible adult or approved person. This may include an older sibling, provided the parents or grandparents have notified the Club of such arrangements.
- Must be 18 years or older to use the Cold Plunge.
- The Pool is reserved for lap swimming only prior to 9:30 am.
- After 9:30 am, the Pool will be open for lessons and recreational swimming until closing.
- During the period June 16 to August 19, a lifeguard will be on duty daily from 11 am-6 pm.
- Proper swimming attire must be worn at all times. The Pool is a family environment and speedos/thongs are not permitted.

Swimming Pool and Hot Tub Continued...

- Children who are not toilet trained must wear a specially designed swimming diaper to use the Pool facilities.
- Glass objects or containers are not permitted in the Pool area.
- Bicycles, skateboards, hover boards, scooters, roller blades, etc. are not permitted in the Pool area.
- Smoking is not permitted in the Pool area.
- Animals are not permitted in any of the Pool facilities.
- Upon indication of thunder or lightning, all persons must exit the Pool until the Club determines the Pool is safe to reopen for use (minimum of 30 minutes).

POOL GUEST POLICY

- All **guests** must be accompanied by a *Host* Member for the entirety of their visit to the Pool.
- **Guests** under the age of 16 must be accompanied by a *Host* Member and a responsible adult or approved person.
- Dispensation may be granted allowing for one **guest** under 16 without a responsible adult with approval of the Pool Manager.
- All members and **guests** must register by name with the attendant and identify a responsible adult. No exceptions.

Children Access/Etiquette

Iron Horse is intended to be a family-oriented Club, and the Club encourages the use and enjoyment of the Club and its facilities by Members, and their children, and grandchildren. Members are responsible for adherence by all children, grandchildren, and their guests to the Club's rules and regulations.

- Unaccompanied children under the age of 10 are not allowed at any of the Club facilities.
- Children must be 12 years of age or older to enter the Fitness Facility and must be 16 years of age or older to use the Cardio equipment.
- Children must be 16 years of age or older to use the Fitness Facilities and Locker Rooms unless accompanied and supervised by an adult. Dispensation may be granted for children engaged in training for sports or related activities at the sole discretion of the Club Manager.
- Children must be 16 years of age or older to use the Golf Course or Practice Facility unless accompanied by an adult. Dispensation may be granted for junior golfers that have demonstrated the necessary understanding of golf etiquette, play proficiency, and maturity at the discretion of the Club's Head Golf Professional.
- Children under the age of 18 are limited to one guest at a time to use the Locker Rooms.

Dress Code

To ensure a pleasant and respectful atmosphere for all members and guests, please adhere to the following dress code:

1. Shirts:
 - i. Men: collared shirts are generally preferred for the Golf Course, Practice Facility and required for all tournament play and in the dining room. Mock neck golf shirts and neat, tidy t-shirts without graphic designs are permitted for the Golf Course or Practice Facility (for example, a small Nike, Iron Horse, or other golf club logo is acceptable, but other graphics, including those from concerts or similar events, are not permitted). Sleeveless shirts are not permitted.
 - ii. Women: Non-collared or sleeveless tops are permitted for the Golf Course and Practice Facility.
2. Bottoms: Golf shorts, slacks, and skorts are permitted for the Golf Course and Practice Facility. Shorts and skorts should be of an appropriate length, reaching at least mid-thigh. Clean blue jeans without holes, frays, or patches are also permitted.
3. Hats: Hats should be worn with the brim facing forward. Both men and women may wear hats in the upper bar area. However, men must remove their hats when in the dining room.
4. Cut-offs, tennis wear, halter or tank tops, gym attire, and swimwear are not permitted for the Golf Course, Practice Facility, the upper bar area, or the dining room.
5. Proper tennis attire is required at the tennis courts at all times, including shirts and regulation tennis shoes. Black soled shoes are not permitted.
6. Proper swimming attire must be worn at the pool at all times. The pool is a family environment and speedos/thongs are not permitted.
7. Children who are not toilet trained must wear a specially designed swimming diaper to use the Pool facilities.

It is expected and required that each Member of the Club conduct themselves in a manner that is respectful of other Members and their enjoyment of the Club and its facilities.
